Interpretation

Definitions

Booking

All members are **REQUIRED** to book their classes prior to attending, no exceptions. Booking is available up to 7 days in advance.

If a member fails to book their class prior to showing up for a class, member agrees to possibly being turned away from participation in that class at the sole discretion of the Staff Member. No credit or refund will be issued if turned away from participation in class.

Member waives their notification of possible class cancellation if member failures to book a class as required. Reference temporary closures in this document.

Members are able to cancel the classes they booked up to 60 minutes prior to start time.

For No Shows - If the class is full and member then no shows for their booked class, member will incur a no show fee of \$45 at the discretion of the Company. Member will be sent an invoice due within 48 hours for any applicable no show fees. If invoice is not paid by due date, member agrees to NOT being authorized to attend any further classes until invoice is paid. In this case, membership will NOT be suspended and billing will continue in accordance with Your Membership Subscription Agreement. For last minute emergencies, please send us a message and we may or may not credit your no-show fee, subject to the Company's discretion.

Membership Term Length and Auto Renew

The Service or some parts of the Service are available only with a paid Membership Subscription. You will be billed in advance on a recurring and periodic basis (such as daily, weekly, monthly or annually, - referred to as the "Membership Term Length"), depending on the type of Membership plan you select when purchasing the Program.

If a Membership Term Length is offered as an auto-renewal service (reference Your Membership Plan Term Agreement), the Company will email an auto renewal notice with any new price increase and terms 75-days prior to Membership Term Length expiration. Member will have 15-days to either accept or cancel the new agreement. Membership Cancellations and Late Payments

If there is a medical reason why the member is unable to continue in their program, pausing billing up to 60 days is authorized with a medical note issued by the members physician outlining the injury, diagnosis with approved exercises and/or physical therapy protocols, and the members recovery time will be needed to be submitted. If medical diagnosis for recovery and return to their 753 Academy program service (paragraph 1 above) is greater than 60-days, the membership will be **canceled**. If members account is cancelled due to medical reasons, the member will only owe two months of the remaining monthly recurring amount paid in full within 14 days as cancellation fee and the normal cancellation policy below will not apply.

You may cancel Your Membership Subscription Agreement anytime online through your member profile or by contacting the Company. You will not receive a refund for any fees You already paid for Your current Membership period and any remaining owed balance in accordance with Your Membership terms will be due prior to confirmation of cancellation by the Company. You will be able to access the Service until the end of Your current paid Membership period, unless cancelled immediately. Members may be billed for a cancellation fee.

If the Membership Subscription Agreement is cancelled prior to the Membership Term Length expiration date a cancellation fee equal to 50% of the monthly membership payments remaining (rounded down) will be owed immediately prior to confirmation of billing notice cancellation. If medical diagnosis for recovery and return to Your Membership Service is greater than 60-days, the membership will be canceled. If members account is cancelled due to medical reasons, the member will only owe two months of the remaining monthly recurring amount paid in full within 14 days as a cancellation fee and the normal cancellation policy below will not apply. To participation in a program after medical cancellation and recovery time is satisfied, a new Membership Term Agreement will need to be completed; Membership terms may change from previous membership terms offered.

Billing

The Member is subject to a separate single \$25 returned payment fee. In addition, the Member is subject to a \$6 late fee for each day the Membership Plan and applicable returned payment fee is not paid (note- the returned payment fee and late fee is in addition to the normal monthly reoccurring payment). The returned payment fee and late fee will be charged separately through either their credit card authorization form on file or through a payable invoice sent via email; which method is subject to discretion of the Company.

After 7-days of nonpayment of the monthly Membership Plan, returned payment fee, and late fee, the membership account will be closed and all remaining balances will be owed in full to include the full amount of the membership plan term length remaining balance as calculated by the monthly membership plan due amount multiplied by the number of remaining billable months to the expiration date, the \$25 returned payment fee, and the \$6 per day late fee. The member agrees that the Company may take any and all measures to legally collect any owed balance, to include at a minimum reporting delinquent account to credit reporting agencies, collections and court.

Fee Changes

No refunds, credits, or prorated cost determination are authorized for holiday closures. If unforeseen last-minute closures take place outside of the published holiday schedule, members that have booked and registered online for attendance of that class will receive a class credit equal to the number of class closure days to their Membership Term Length expiration.

The Company agrees to provide access and services in-person with an option for online training in case of scheduled holidays, mandatory government closures for pandemic, State of Emergencies, wildfires, riots, extreme weather, renovations, repairs, unforeseen and unannounced emergencies, and forced closures. Temporary closures of a class may happen due to uncontrollable and unforeseen circumstances. In the event of a closure of a class with no online training available, the registered members for that class will be contacted and will receive class credit equal number of class closure days at the end of their membership expiration term.

Free Trial
